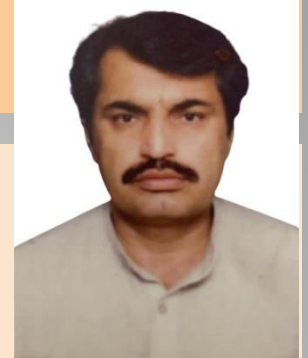




## **BRIEF HISTORY OF CHAMBER:**
